RO Training and WTC (What's the Call)



At the Huntsman Senior Games I was asked to be the match RO, which I was honored to do. During the match I was asked to make two calls.

The first: Shooter comes to shooting position and puts rifle down. TO notices that the hammer is cocked and declares a Stage DQ.

In the last several years the ruling on hammer back has been changed twice.

Originally if the shooter left the loading table with hammer back it was an SDQ. This was changed to as long as the shooter remains in contact with rifle the shooter is able to demonstrate by pointing the rifle

down range and pulling the trigger. This was then later changed to allow the shooter to put the rifle down and then pick it up and demonstrate that there is not round in the chamber.

Second: Shooter finished rifle, safely restages rifle then picks up shotgun. TO then stops the shooter and claims that there is a round in the rifle. The shooter then restages shotgun and picks up rifle, cycles rifle and the rifle was empty. Spotters say the shooter shot ten rounds. The TO then declares TO interference and directs the shooter to unloading table. Because this was a reshoot the Match RO needed to be informed, which I was. OK so why am I telling you this? Well, the TO did not count the rounds correctly, that happens, but the TO should have had the shooter continue to finish the stage without interruption, THEN check the rifle. Also, the TO should have insisted the shooter finish the stage.

In both of these examples the TO's were **VERY experiences** shooters, yet they were not current with SASS rules and guidelines. Therefore, I will repeat the following paragraph from the last newsletter.

It is my opinion that the true value of the courses is the participants. The material has value, especially if you have never taken any SASS courses. The greatest value is the discussions between the students. Even if you have taken the courses in the past, I would hope you would participate in the next offerings, probably May 2026. Especially the experienced members. **You, the experienced shooters**, have tremendous value in your experiences. I would also suggest you might refresh your knowledge base. Please make an attempt to attend.

COWBOY & Wild Bunch Issues

Here are summaries of the TG meetings at Land Run. If you would like to see the full meeting note let me know and I will pass them along.

Land Run CAS TG Meeting notes

- a. Structured Annual Agenda didn't happen because there weren't any items up for discussion/consideration.
- b. Ladies Category parameters
- i. Category discussion "OPEN categories, Base categories, protected categories" *confirmation/clarification provided re: female at birth requirement for ladies categories (policy change earlier this year)*
- 4. TO Training Module Updates

Misty presented that the TO Training Module is in the works. Video footage of scenarios is achieved, planning for the TO Training Module to be finalized and available by January 2026.

- 5. Match Directors Guide Updates
- Once the TO Training Module is complete, SASS will move on to the production of an updated match director's guide.
- 6. Roy's Creek Dan ROC/TG OK: Need to clear up the confusion about the hammer back on the rifle. If the rifle leaves the shooters hand before the hammer is noticed.
- Misty was able to locate an email thread from the ROC from 2020 on this topic. It was clarified that there is no penalty if it is corrected before firing the next firearm. Misty will work with the CAS ROC to

obtain an official clarification. Furthermore, this is an item that likely needs to be added to the SHB to help avoid future clarifications being needed.

Reducing the penalty for failing to clear guns at the unloading table to a Minor Safety penalty rather than a Stage DQ

This item died without discussion.

8. Randy St. Eagle, TG – TN – Definition of "Revolver in Hand" SHB pg. 45 Revolver in hand – when the muzzle of the revolver clears the mouth of the holster or breaks contact with a prop where it was initially staged.

After presentation and discussion, it was deemed necessary for a revised definition of "Revolver In Hand" in the SHB for 2026 to help with clarity on this situation. Misty/SASS and the CAS ROC will work together to compose a more thorough definition of "Revolver In Hand".

9. NEW BUSINESS – FLOOR OPEN TO NEW/ADDITIONAL ITEMS

- Montie Montana, TG presented the request for a 90+ category
- Santa Fe River Stan, TG-FL Proposal to remove the outdated verbiage surrounding a gun that falls (breaking the 170 vs. not breaking the 170)... instead; "any gun that falls" regardless of circumstance earns the penalty. *Misty asked if SASS and the ROC compile the information and proposed new verbiage, would the TG Body be willing/able to vote on this item prior to Jan 2026- all TG's in attendance agreed. Misty will spearhead the voting process for this item.*

Land Run WB TG Meeting notes

Within the next few weeks, SASS will be working with the WB ROC and will finalize the voting items. Misty Moonshine

There was some discussion surrounding the questions and to who/by whom the survey questions should be sent out, as well as the intent of the survey.

Misty Moonshine presented that, while SASS is certainly willing to send out surveys to the SASS membership, by SASS HQ doing so, it circumvents the TG body and its role. Instead, it was suggested that SASS HQ do the legwork to compile survey questions surrounding the existing 2025 agenda items for TGs to use to poll/lead conversations within their region with shooters and the clubs they represent. Further clarification was provided in terms of what items (questions) are "voteable" vs. what falls under SASS business policy.

3. Clarification (will be included in the 2026 SHB edits) re: 3 dot sights being allowed.

- 4. Brief discussion surrounding increasing the maximum pistol weight to 43 and CC Moonshine, SASS Advisory Board member presented the reasons behind the consideration.
- 5. Cholula Mike presented Wiley Fox's TG Wire Forum post/response to the survey questions as requested by Wiley.



Huntsman Senior Games

Starr, Red Ryder and I attended the Senior Games October 7 – 11. It was held at the Dixie Desperadoes range in Hurricane (St George) Utah. I would suggest that if you have the time this is a great range for Cowboy Action Shooting. The range is dedicated to our sport. In addition to 12 separate developed bays there are two practice bays, a man-on-man shoot-off bay, 200 yard rifle bay and a 500 yard long range bay. They have a covered pavilion, water and enclosed porta-potties. Free dry camping and several RV campgrounds nearby. The club does a GREAT job supporting our sport. I would offer that it is the best range we have used (Jerome ID is a close second). Starr was 2nd in her age group. I was second in Wild Bunch Traditional Senior and third in my cowboy age group. Oh, BTW, you are assigned to your actual age group, no category shopping. We plan on attending next year and would encourage you to think about also attending. At \$150 for a large annual event (T-shirt, shooter gift, one lunch and banquet dinner, is well within the rates charged by other clubs. All events are included. 18 side matches, Wild Bunch and Plainsman. The age grouping for this start at 50 in 5 year blocks. Huntsman awards an abundance of metals, to the 107 shooters.
