Critical information – please read!

Silver State Shootists is going to experience major changes this year. With the situation at the Carson range and a number of board members retiring, we are at a major crossroads for the club.

RANGE OPTIONS AND OUR FUTURE

Doc and Jackpot have been searching for a permanent range for the club. At this time we must assume that the Carson Range is closed to us for at least the rest of the year. The option that many on the board prefer is for us to find a permanent range in the Virginia City area.

Doc and Jackpot met with the Storey County Sherriff for a really good meeting to discuss locations. Like us, they can no longer use the Carson City range and are looking for a permanent place to shoot and qualify. We have their permission to look for a “joint” facility which should help us with landowners supporting our search.

Jackpot and Doc spent a day looking at locations in the Virginia City area. Both of them liked a location in Gold Hill that would support multiple posses and had very good backstops for safety. Doc reports that the property that we looked at by the Gold Hill train depot is, according to the Assessor’s office, owned by several entities. The most useful of the parcels is owned by Union Mining Corp that is defunct with no one claiming ownership. From what Doc found out, if we were to shoot on that property no one would object. The adjacent property to Union Mining is owned by Sutro Tunnel. There are other parcels there as well but with no owner because of contested boundaries. The sheriff said that he has no problem with us shooting at this location.

Doc talked to Scott Jolcover, the General Manager of Comstock Mining and he found that Comstock doesn't have anything that would work for us.
